Dear ladies and gentlemen,

my name ist Thomas Ernst Wanger. I am art historian and the brother of Dr. Markus Wanger. I have the honour to make the exhibition in your office with art paintings of Markus Wanger.

Iwould like to give you some important informations:

One big and heavy wooden box in the sice of $1750 \times 1100 \times 600$ mm is going to arrive this Thursday at your office in Brussels. The transport firm will contact you and they will tell you when they will arrive at your office, that somebody is there to accept and somebody has to tell them where the box has to be brought.

As the box contents the paintings of Markus Wanger it is of first importance that you choose a dry and safe unloading point nearby or in your office. For example in your garage. Please pay attention if the garage is low and do not forget that we also have to put out the paintings as well.

If it is not possible for you to leave the box somewhere in your building you should open the box as I have marked at the four sides of the box. Please put out the precious paintings one by one in the manner of the illustration and carry and store them like it is shown in the illustration which is in addition to this message. Please bring the paintings to a dry and safe place in your office.

If you have somebody who is able to and knows how to handle and unpack paintings: this person will be allowed to unpack all the paintings so that they can breath. But please store the paintings like it is shown on the illustration. Please

do not throw away the plastic and keep it up. If the person is in hurry or uncertain it should not be allowed to unpack the paintings.

We will arrive in Brussels on Sept. 30 th about at 15 min. past 11 a. m. So we would like to visit your office three hours later at 2 p.m., if this is possible for us and you. It would be great if we could work for the exhibition on this afternoon and probably also in the evening, as well as on the next day and the day of the opening of the exhibition from morning until afternoon, if necessary.

Daniel Mörler has told me that you have a caretaker who may help us to fix the paintings at he wall. There are 18 paintings that are going to be placed for the exhibition. We need a leader and an electric borer, that was not allowed to bring with by plane. If you have a special system in use for hanging and changing paintings in your office it would be the best if we would be allowed to use it. So it would probably be necessary that you buy your own hanging - string - system for our 18 paintings soon.

Please tell your caretaker that we are going to make the exhibition on Sept. 30th in the afternoon and evening, as well as on October the 1st in the morning and if necessary until the afternoon and that we would be grateful for any help.

The new paintings of Markus Wanger are absolut fantastic and they were partly shown already in Gaschurn, Austria at he beginning of this year with great success. I have already made exhibitions in Austria, Switzerland and Liechtenstein and I am looking foreward to the exhibition in your office.
